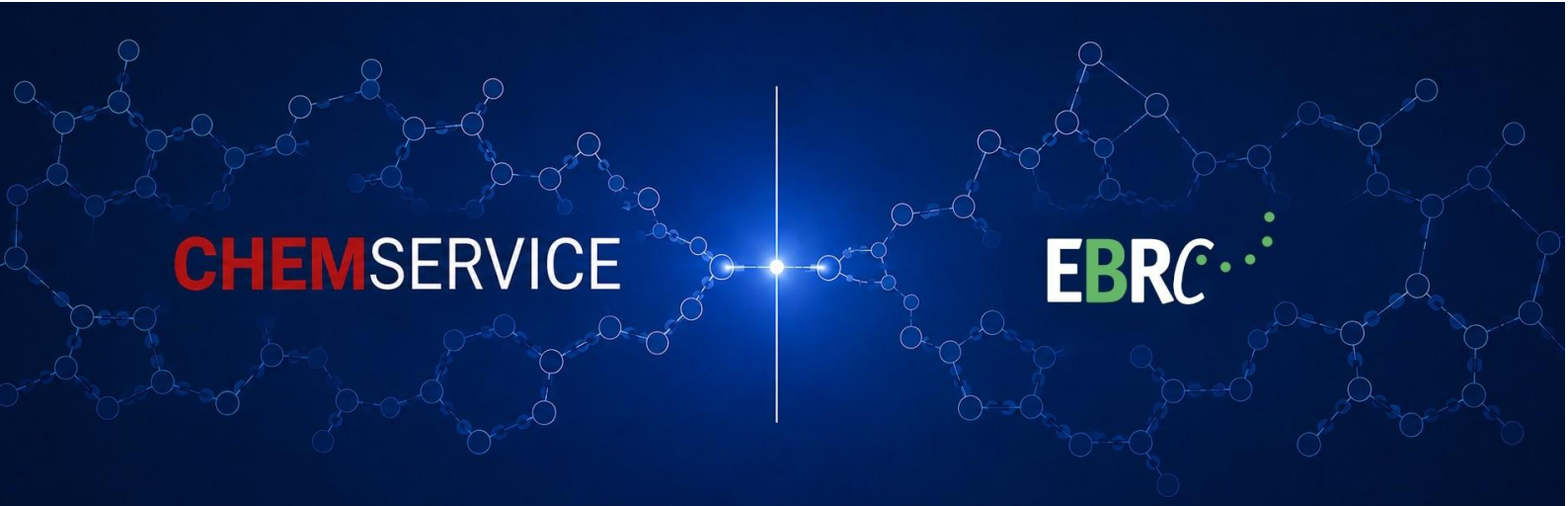




Chemservice and EBRC join forces to create a leading European Regulatory Compliance Specialist for the chemical and adjacent industries
